Minutes

Call to Order: Chairman Mary Ann Durick called the meeting to order at 12:02 pm.

1. Reduced Fee Licensing Schedule for 2018

Director laCour stated that in the past few years the Racing Commission has approved a reduced fee schedule for license applications that are submitted prior to the race meets. Participation has slowly but steadily increasing and he asked for this to continue for the 2018 race meets.

<u>A motion was made</u> by Commissioner Martin and seconded by Commissioner Piepkorn to approve the reduced fee schedule for 2018. Martin –Y, Piepkorn -Y, Durick –Y, and Kreidt -Y. Motion passed.

2. Administrative Rule Changes

a. Post Race Season & Social Games Final Approval

Director laCour provided an update on the Administrative Rule changes noting that there was a public hearing and no one from the public attended and no comments were received. He asked for authorization to submit the changes to the Attorney General's office and subject to their approval, to send to the Administrative Rules Committee.

A motion was made by Chairman Durick and seconded by Commissioner Martin to authorize Director laCour to submit the Administrative Rule changes to the Attorney General's office and subject to their approval, to send to the Administrative Rules Committee. b. Tournament Wager Variance

Director laCour requested a variance pursuant to ND Admin. Rule 69.5-01-02-01(2) "in the best interest of pari-mutuel horse racing" to allow the fantasy tournament operators to proceed with using the rules as amended.

A motion was made by Chairman Durick and seconded by Commissioner Martin to approve a variance pursuant to ND Admin. Rule 69.5-01-02-01(2) to allow the fantasy tournament operators to proceed with using the rules as amended. Durick - Y, Martin -Y, Piepkorn -Y, and Kreidt -Y. Motion passed.
