- 1. A Business Plan demonstrating revenues and costs expected from operations including full disclosure of all fees and other financial considerations related to the operation of simulcasting and/or account deposit wagering, i.e., a pro forma operating statement for the anticipated license year.
NOTE: Applicant may be required, after consideration of applications by the North Dakota Racing Commission, to submit an independent CPA audit and may require a SAS 70 audit including the year-end prior to issuance of license.
- 2. A description of all "Know Your Customer" and Anti-Money Laundering policies and procedures. The description must detail all systems and procedures used to validate identity, age and jurisdiction of legal residence of account holders including checking account holders against the specially designated nationals list maintained by the United States Department of Treasury and the designated foreign terrorist organizations list maintained by the United States Department of State. Where services are rendered by a third party, that third party must be identified and a description included of all processes and procedures for the services provided.
- 3. A detailed description of all payment processing systems and procedures. Where services are rendered by a third party, that third party must be identified and a description included of all processes and procedures for the services provided.
- 4. The procedures to ensure the legality of wagers accepted including the current legal status of each jurisdiction from which customers may wager.
- 5. A description of the processes and procedures implemented by the Organization or in conjunction with tracks and other industry stakeholders to address potential odds manipulation through placing large bets on small pools, the cancellation of wagers, and other methods.
- 6. A copy of rules governing the acceptance and management of accounts, and copy of any changes in such rules at least thirty days prior to the effective date.
- 7. All bank accounts and bank account numbers used to maintain a separate record of all revenues collected by the applicant and the distribution of such revenues. The principal address of the bank and contact information for the bank employee overseeing the accounts must be included.
- 8. A copy of Certificate of Incorporation.
- 9. The applicant's history and experience in gaming and wagering activities. This statement must include any rulings, fines, penalties, or investigation in regard to the applicant or principal officers of the applicant.
- 10. A brief biographical history of the owners and managers of the operation. It should include professional and employment background.
- 11. A list of any arrests, misdemeanor or felony history, if such exists.

12. Provide, as an attachment(s), a Financial Statement of the applicant including, but not limited to, the following:

- Balance sheet through the quarters:
 - ended June 30 of the current year
 - ended June 30 of the previous year (*new applicants only*)
 - ended June 30 of the two (2) years previous (*new applicants only*)
- Income and expense statements through the quarter ended June 30 of the current year and for the year ended previous December 31.
- Copies of any loans or other operating agreements between the applicant and persons or entities having a proprietary or other interest in the applicant which are not reflected in the applicant's financial statement.

List all current licenses covering wagering operations in any other jurisdiction. Identify all websites, simulcast sites, and any other wagering operations associated with those jurisdictions. A physical copy of each license must be included as an attachment.
